TAMPA – Vicki Marsee, RN, MBA, FABC, has successfully completed two professional examinations and is now certified in Healthcare Compliance (CHC) and as a Compliance & Ethics Professional (CCEP). Marsee is vice president/Ethics and Compliance Officer with Chapters Health System in Tampa.

The CHC credential ensures that compliance professionals have a thorough understanding of the federal, state and local regulations that govern the delivery of healthcare. The CHC examination is administered by the Health Care Compliance Association, which developed criteria for the determination of competence in the practice of healthcare compliance at a variety of levels and recognizes individuals meeting these criteria.

The CCEP designation provides individuals the platform to demonstrate knowledge of relevant regulations and expertise in compliance processes sufficient to assist corporate industries to understand and address legal obligations and promote organizational integrity through the operation of effective compliance programs. The CCEP examination is administered by the Society of Corporate Compliance & Ethics, which is dedicated to enhancing the role of compliance professionals and advancing corporate governance, compliance and ethics on a global scale.

Marsee joined Chapters Health System in 2010 and as vice president/Ethics and Compliance Officer oversees quality, compliance, safety, risk management, infection control and employee health.
